Purpose of data processing

7. Duration of data processing

The Data Controller has set the data retention period at 5 years.

The extension of data processing can only be based on your consent.

8. Identity of potential data controllers, access to data, storage of data

The data provided to the Data Controller shall be processed by the Data Controller's staff in the following positions:

- Preparatory engineer

The Data Controller stores the Data in its own electronic systems.

9. Right to decide on automated decision-making in individual cases, including profiling

- d) to obtain, at his request and in further cases as set out in this chapter, from the controller the restriction of processing of his personal data (hereinafter "right to restriction of processing"),
- e) to obtain, at his request and in further cases as set out in this chapter, from the controller the erasure of his personal data (hereinafter "right to erasure").
